**Addendum for sales and exhibition display contract/invoice at the Cleveland Labor Day Oktoberfest, held at the Cuyahoga County Fairgrounds.**

### **REGULATIONS**

1. Exhibitors may begin set up Thursday August 30, or date approved with event management.
2. Exhibitors are required to be open for business each day at the above scheduled times.
3. Cleveland Labor Day Oktoberfest will provide the contracted space and one 8' long table per space upon request in advance.
4. We would like to have all table skirting in typical light blue and white Bavarian checkered material
5. Exhibitors must assume responsibility for the safety of their merchandise and displays against loss or damage by fire, theft, accident or any destructive causes while on the property of the Cuyahoga County Fairgrounds
6. Assignment of display space is final, and shall constitute an acceptance of this contract. Use of display racks for self supporting boards or structures that fit in to assigned space is all that will be acceptable
7. Electricity will be available for all assigned locations.
8. Storage of all extra merchandise, cartons, and containers must be out of sight.
9. All merchants are solely responsible for compliance with applicable state laws, Ohio 7.75% sales tax (Cuyahoga County), local ordinances, and health regulations.
10. Security will be provided by local police. The building will be locked each evening and will be unlocked each morning 1 hour prior to opening to the public.
11. By Cuyahoga County Fairgrounds rules, there is **NO SMOKING** in any building.
12. Badges/Credentials for two staff members will be provided.

### **LIABILITY**

Cleveland Labor Day Oktoberfest shall not be eligible for any refunds or other expenses incurred by exhibitors, if it becomes necessary to invoke these regulations. Cleveland Labor Day Oktoberfest shall not be liable for non-fulfillment of commitment for delivery of space by reason of exhibition premises being damaged, destroyed or rendered unusable due to fire, accident, act of God, or public enemy, strikes, authority of law, or any other cause. In the event that the exhibition cannot be held or space delivered for that purpose, Cleveland Labor Day Oktoberfest sole liability shall be to reimburse the exhibitor pro rata on moneys actually paid in by such exhibitor, less any charges incurred by Cleveland Labor Day Oktoberfest for advertising, administration and similar costs.
